### **Description of Grant Proposal:**

#### Objectives of grant proposal:

This grant would provide detailed follow-up to an August 2006 trip to the Great Barrier Reef in Australia, with the goal of preparing a chapter on the links between eco-tourism and climate change along the reef. More specifically, my objectives are four-fold:

1. Compare and contrast eco-tourist operations in Townsville, Magnetic Island, Port Douglas, and Cairns, Australia.

2. Meet with Great Barrier Reef Marine Park Authority (<u>http://www.gbrmpa.gov.au/</u>) at their headquarters and visit education center at Reef HQ Aquarium (<u>http://www.reefhq.com.au/</u>) in Townsville.

3. Attend Local Marine Advisory Committee meetings (<u>http://www.gbrmpa.gov.au/about-us/local-marine-advisory-committees</u>) in three of their twelve locations, namely Douglas, Cairns, and Townsville.



4. Attend at one of the four Reef Advisory Committees, particularly the Ecosystem Reef Advisory Committee or the Tourism and Recreation Reef Advisory Committee.

### Describe the expected outcome(s) for this project (publication, performance, exhibit, paper).

The expected outcome of this project is a chapter on the Great Barrier Reef of Australia for a larger work on eco-tourism and climate change. I have shared an introduction of this larger project with my former editor, now editor-in-chief at Dartmouth and University Press of New England. She is interested and has asked me to send her a full book proposal. I also plan to consult with presses such as Sierra Club Books and Island Press for this project. The work will be organized around a series of case studies rooted in personal research and travel across all seven continents, including particularly work with scientists at Tambopata Research Station in the Peruvian Amazon and Hluhluwe-iMfolozi National Park in South Africa's KwaZulu-Natal province, notable as Africa's first protected conservation area and savior of the black rhino. Additional chapters will target the peninsula of Antarctica and Ecuador's famous Galapagos Islands.

#### Describe how this project relates to your current expertise.

As can be seen in my enclosed short vita, this project stems from my expertise in sustainable development and climate change politics. In fact legwork for *Tales of an Eco-Tourist*, incorporates data from over 20 sites over the last decade, including both here in the states and abroad:

#### Describe the relationship of this project to your long term professional goals.

This project fits well with what I see as the heart and soul of a liberal arts college, the synergies among scholarship and teaching as well as service. For one, I hope to continue to build on my reputation as a sustainable development and climate change politics scholar with this project, opening new doors as a speaker for the local community and beyond, i.e. echoing past engagements with the State Department, League of Women Voters, etc. For another, as noted in the contributions to Rollins College section I believe this project enhances my course offerings here on campus. And finally, in terms of scholarship this project builds on a concerted effort over the last several years in the arena of eco-tourism. More expressly, the past two years I have written a number of reviews and review essays for leading journals in my field on climate change politics, and this project would in many ways be the culmination of those efforts. Finally, I also see this project as one rich with potential for further investigation, including work with Rollins undergraduates.

#### Describe the contribution this project makes to your field and to the academic community.

Tourism is one of the largest industries in the world and ecotourism is the fastest growing sector within that industry. Having become the principle export in 83 percent of the developing world, tourism offers remarkable potential to link conservation interests to economic development. The developed world, in turn, can better understand the process of climate change and the dangers it presents with such firsthand experiences. This second component and its emphasis on the developed world is just as critical as the first as it helps open the eyes of people outside the Global South as to



how their daily lives connect to the places they are visiting. Ecotourism can be a practical political tool for local communities to develop to their advantage (albeit with costs as well), but it is also a remarkable avenue to link global and local phenomena tied to climate change. As such this project builds on arguments articulated by those such as Michael Schellenberger and Ted Nordhaus in their much ballyhooed "Death of Environmentalism" piece delivered several years ago at an Environmental Grantmakers Association meeting, arguing that environmentalists must avoid characterization as a special interest and embrace ecological arguments within policy issues such as health care and job creation.

### Describe the contribution this project will make to Rollins College.

This research project will benefit several courses I currently teach on a regular basis, particularly a course on case studies in sustainable development and another one on global environmental affairs. But the biggest impact would be to lay groundwork towards the redevelopment of a former RP course on climate change politics into an honors course that would be taught with a colleague in the sciences division in approximately two years.
